Please read and initial each of the following terms and conditions of enrollment at Casa Esperanza Montessori Incorporated:

_____	<p>I understand that the total cost for the half-day, private, tuition based, Children's House Program for the 2011-2012 Academic Year is \$5400 (without tuition insurance) or \$5600 (with tuition insurance). The total includes a non-refundable registration fee of \$400 and tuition payments totaling \$5000.</p> <p>A discount of up to \$150 is available if tuition is prepaid or if Casa Esperanza Montessori Charter School does monthly bank drafts.</p>
_____	<p>I understand that tuition insurance at a cost of \$200 is only available at the time of initial application. Tuition insurance releases parents from the financial obligation to pay yearly tuition due to the unanticipated early withdrawal of their child from the preschool program.</p> <p>I further understand that if the optional \$200 tuition waiver insurance is purchased and it should it become necessary to withdraw my child from the preschool during the academic school year, a 30 day written notice is required to be sent to: Admissions Processor of Casa Esperanza Montessori Preschool, 2600 Sumner Blvd., Suite 130, Raleigh, NC 27616. In the event of any such withdrawal, I understand that I am still obligated to pay tuition due, calculated at \$30 per day, from the first day of school through the end of the 30 day notice period.</p>
_____	<p>I understand that all tuition payments are due and payable on the 1st of the month as outlined in the payment schedule at the end of the contract. I understand that if payment is not received by the 15th of the month my child may be denied attendance until payments are current or my child's spot may be offered to a family on the waiting list.</p>
_____	<p>I understand that, the total tuition for the year as specified on the payment schedule, is due even when the school is closed due to school intercessions, federal and/or state holidays, teacher work-days, and/or weather-related events or when the child is absent from school due to illness, personal vacation or other similar reasons. I understand that all payments must be current in order to register for the following school year.</p>
_____	<p>I understand that my child's place in the class will be reserved on behalf of my child only after Casa Esperanza Montessori Incorporated has received and accepted (i) this fully completed and signed Preschool Enrollment Contract, and (ii) the \$400 registration fee has been paid.</p>
_____	<p>No portion of any tuition or fees paid in advance will be refunded, including but not limited to deposits, registration fees, and tuition insurance.</p>
_____	<p>I understand that if tuition insurance is not purchased, even if my child is no longer able to attend Casa Esperanza for any reason, I remain obligated to pay all amounts due.</p>

_____	I understand that I am obligated to abide by the conditions set forth in this contract for every preschool class placement, even if my child's class placement is changed due to individual or school needs.
_____	I understand that if my child must be excluded by administrative decision from school, for reasons other than late payment, no refund will be provided; however, no further financial obligation will exist. In the case of late payment, all financial obligations continue.
_____	In addition to the tuition payments and fees described above, I understand that I will be charged for after-school care at the prevailing rates if my child is not picked up before the end of afternoon carpool.
_____	I understand that accepting placement in the Casa Esperanza private, tuition based, Children's House Program, whether Preschool or Kindergarten, does NOT guarantee a place in the Casa Esperanza Montessori Charter Program. All spaces for the Charter program are given via lottery as stated in the Charter School agreement with the State of North Carolina Department of Public Instruction.
