V. NEW BUSINESS

 The Head of School shared the highlights of quality educational experiences that students were having with the Artists in Residence who have been working with all our students for one week. She expressed her gratitude to the Parent Faculty Association for sponsoring it for all Casa students. This year the topic selected conflict resolution and the history of our native American tribes and their quest for peace. Students have been writing mini plays and rehearsing. Parents will have the opportunity to see their product.

- The School potluck event was very successful. Teachers provided parents presentations about our Montessori philosophy.
- The Head of School informed the board about additional quality cost free training in math and literacy provided by Department of Public Instruction. Three Casa teachers have been sent to the Math Foundations training and many others are also taking the on-line Reading Foundations training.
- Upper grade level teachers were introduced by the HOS. They provided a presentation demonstrating how they developed curriculum in the areas of language arts and math K-6th integrating the North Carolina Standard Course of Study with our Montessori best practices. They are hoping to continue developing curriculum in all subject areas next summer.
- The calendar for SY 2019-2020 was created during intersession. It will be shared with teachers first before going out to the public.
- PFA bought and installed the new playground equipment, still need donation to continue expanding further for upper grades.
- Sra. Nunez and Dr. Jailall attended the Charter conference and shared information regarding a grant.
- Septembers Finance Dashboard at 523 charter students and 23 for pre-school; staffing remains the same.
- BASC enrollment figures are 112 students with staff children, paying students are at 91.
- Pre-School and BASC. We are falling behind on preschool students, currently we have less than projected.
- Did not get the monies we expected from the School Supplies.
- Salaries are right on target
- Spending is higher for first quarter because of the start of the school year but will level off when spending stops.
- Review and approval of new budget outlined in board packet.

Mr. Chilton makes a motion to approve the new revised budget, Mr. Slipsky seconded and all approve 8-0.

- Proposed modification to the admissions policy for review and will need an approved policy by next month for lottery registration in January.

February 2018 repair expense to be approved

We need clarity and vision of what we need, a long term plan (4-5year financial model). Demonstrate solid performance, which we are shaky now. Build to suit is the best way to go.
